To ensure that your (planned) internship meets the requirements of the orientation internship, this form must be completed by your home university. If you receive a study place at the University of Mannheim, this form must be submitted to the Regierungspräsidium Stuttgart for review when submitting the request to have your degree recognized as equivalent. Please pay attention to the correctness and completeness of the information.
